## **Counseling Services Information**

### **Cost:**

All counseling services provided at the Stanislaus Pride Center are free of cost.

### **Available services:**

Individual and/or couples counseling services will be provided by Dr. Gina M. Pallotta or a Marriage Family Therapist Trainee or Intern supervised by Dr. Pallotta. Counseling sessions will be available on a weekly or biweekly basis.

### **How to make an appointment:**

If you are interested in receiving counseling services you may call Dr. Gina M. Pallotta at 525-8799 to schedule an appointment. You also need to complete the attached application form and bring it to the first session.

### **Confidentiality:**

All counseling services are confidential unless you are going to harm yourself or someone else or in cases of suspected child or elder abuse. If you have additional questions about confidentiality you may discuss them with Dr. Pallotta prior to scheduling an appointment.

### **Services to individuals under the age of 18:**

All counseling services for individuals under the age of 18 require parental consent. This requires that a parent or legal guardian attend the first session and sign the attached application. The only exemption to this legal requirement is if the minor has been the victim of abuse or if the minor is going to harm themselves.
